(Two Shores) am arm's length creditor (the "**Creditor**"), pursuant to which the Company has agreed to issue an aggregate of 500,000 common shares purchase warrants ("**Warrants**") exercisable at a price of \$0.55 per share for a period of 24 months from the date of issuance. Assuming full exercise of the Warrants, the Company will issue 500,000 common shares in share capital of the Company.

The total amount of indebtedness settled by these arrangements is \$141,750 owed by the Company to the Creditor pursuant to services provided over a 12-month period commencing October 1, 2021. The Company decided to satisfy this outstanding indebtedness with Warrants in order to preserve its cash for operational purposes.

Two Shores has been a strategic partner that has supported SBBC and its subsidiaries with strategic advisory and working capital for its blue-chip retail customers such as Costco and CVS. The Company looks forward to a continued relationship with Two Shores as it continues to build out its retail business.

This arrangement is subject to the approval of the TSX Venture Exchange ("**Exchange**"). The Company will issue these Warrants, which are subject to a four month hold period, once approval has been received from the Exchange.
